Some thoughts on insurance

Recently I had to renew my Building & Contents Insurance and the local broker got me a better deal on the same terms as the company I had been with. I took the better deal! However, when I got home I had a quick look at the documents and noticed the usual £2,500 cover for garages. I got in touch with the broker as my previous insurer had agreed to cover the contents of the garage within the overall cover for the house contents. The broker asked me to do a rough estimate of the cost of new-for-old replacement of the garage contents. I got to £13,500 with most of the woodturning stuff done but I hadn't done my woodworking tools or the garden equipment so I suggested to the broker that I would need £20,000 of cover. The insurer agreed under the same terms as before, no extra charge but added that this DID NOT COVER THEFT. This, I discovered was the same as the previous company but they didn't mention that bit! I stated that I could live with that but during the last "Zoom" session the lack of theft cover was questioned. After thinking about that I went back to the broker but they were unable to find a company that would cover the garage contents

for theft despite it being attached to the house and is alarmed. Once again, a suggestion from the "Zoom" meeting about a company that could help led me to their office in Armagh. Including an additional £20,000 cover the garage contents their initial quote was LESS than the cheaper quote I had though when I added accidental cover and cover for valuable items away from home, I did end up paying more. BUT IT WAS WORTH IT FOR THE PEACE OF MIND!

I accept that I do have a big workshop and plenty of equipment but I would be surprised if £2,500 was enough to cover the tools and equipment that most of you would have. I suggest you do a check and if you feel that the cover is inadequate talk to your insurance broker/company.

RVH Children's Hospital

Jenne and her staff, thank you again for the fantastic effort you made for the Hospital back in June. In the present circumstances it was a great credit to you all.

For Christmas Jenne and her Play Team would be very grateful for trees and snowmen but, new for 2020, she has asked if we could make some penguins as well. Wood for these three (8x4x4 timber) is in a large box at the door of the Wood Shed – not much left now. Just help yourself - you don't have to enter the

shop unless you want to, of course. Jenne has asked if it would be possible for some rings for the babies – like curtain rings. About 50mm diameter with a 30mm hole. NOTE that these are for the babies and MUST be made from SAFE WOODS like Sycamore, Maple, Beech. You can also make rolling pins for Play-Doh if you want to do something different.

All of the work for the Children's Hospital should be with Eugene or in the Wood Shed by 14th November.
